



More mares were purchased during a second trip in 1876.

A journalist visited Fulham Park Stud in late summer in 1884 and provided the following account of the property:

A very easy jaunt from town to any lover of good horse stock is Fulham Park, on the Henley Beach Road.... Just at this season of the year the paddocks by the roadside, which are famous for supplying the best lucerne obtainable in the colony, fill the air with a beautifully fresh perfume... Mr Blackler has built his homestead so far back from the road that its roof only is visible from the tramcar and one has to traverse a good-sized paddock ere he finds himself at the bridge across the Torrens by which access is gained to the stables and homestead of Fulham. These are partly enclosed with fine trees, and even on a tolerably hot day there is shelter and cool shade for

Under Blackler, the Stud enjoyed significant success, producing horses that went on to win major Australian races including the Melbourne Cup, Caufield Cup, Caufield Stakes, VRC Derby, Adelaide Cup and Goodwood Handicap. Blackler died in 1896. The Stud passed to his son, WA Blackler, who continued with its operation until his declining health saw the property sold to Sir Sidney Kidman in 1912. 




Tree Survey in Glenwood Reserve – Selected Results



- 64% (16 trees) are either Regulated Trees or Significant Trees under the *Planning, Development and Infrastructure Act 2016*. All but one are survivors of the original planting.
- 36% (9 trees) of the original / historic planting have been replaced due to death, poor health or safety reasons



Only 11 trees (44%) in the avenue exhibited GOOD Tree Structure



16 trees (32%) exhibited a high level of canopy thinning, possibly due to soil moisture stress

" Of concern is the number of trees that are **not** in good condition. This is likely due to a combination of factors:

- a dry summer, diminishing groundwater
- climate change impacts (recent & cumulative)
- irrigation unsuited to deep-rooted trees
- root disturbance by construction of park furniture and regular use of reserve by a heavy vehicle"





PROPOSED PICNIC SHELTER AT GLENWOOD RESERVE

Glenwood Reserve contains an avenue of Historically Significant Trees which are survivors of the former Fulham Park Stud owned by Sir Sydney Kidman. These trees are River Red Gums – a species native to SA - which were planted here over 90 years ago. The age of the trees, their historical origin, and their configuration in a long avenue between the River Torrens and Valetta Road, all contribute to their significance. This tree avenue is a key feature of the "Fulham Park Stud" Heritage Place. As a regular visitor to the reserve over the past 12 years, it has become evident to me that the trees are vulnerable.

I learned of the picnic shelter proposal when approached by a local resident, Don Lee. Apart from questioning the need for a new picnic shelter, we felt that it would be inappropriate and intrusive for the reserve. Concerned also about recent tree losses, and the ongoing threat of climate change, we undertook a survey of the trees in Glenwood Reserve and Park Drive in January.

Results of River Red Gum Survey

Significance

- Total: 44 trees (25 in Glenwood Reserve, 19 in Park Drive median)
- 17 Significant Trees (11 + 6)
- 11 Regulated Trees (5 + 6)
- TOTAL Significant or Regulated = 28

Tree health – Glenwood Res. only

- Only 11 of 25 trees had "Good" tree structure
- 9 of 25 trees showed "Moderate" or "High" degree of canopy thinning
- 5 trees with "High" canopy thinning were in close proximity to park furniture (i.e. playground, swings, picnic table); The Tree Protection Zones (TPZ) of 4 of these trees have been encroached on

We also note: A new Swings area installed in recent years next to a large tree resulted in the tree's removal following the fall of a large limb.

Further, we noted the following...

Lost Green Space in Glenwood Reserve

• Total loss (including proposed picnic shelter): 300m² (3.6%)

Local picnic shelters

- 4 Picnic Shelters within 415m
- Closest is 270m to west (Shelley Reserve)
- 3 at Collins Reserve

In summary - our key concerns:

- Existing structures are already too close to the trees encroaching on Tree Protection Zones (TPZ). Position of the new (proposed) picnic shelter narrowly avoids the TPZ of the nearest tree, but may still require partial canopy removal.
- Picnic Shelter will be a significant intrusion on the character and visual amenity of the heritage tree avenue thus impacting on the integrity of the Heritage Place.
- It will result in further, *incremental loss* of much needed green space
- With no other intervention here, water management and climate stress *remains* a serious threat for the longevity of the heritage trees (the key management issue)
 - Climate stress on the trees is already significant without the need to impose any further stress from additional infrastructure development in GR.
 - The sudden death of 5 large trees in Park Drive during the 2019 heatwave highlights the narrow margin of survival - even for large, mature trees - during extreme weather events (which are becoming more frequent)
 - The existing irrigation system whilst suitable for grass is of limited benefit to the deep-rooted River Red Gums which depend on periodic flooding or a shallow aquifer.
 - AdaptWest Climate Change Adaptation Plan predicted in 2016 the following for western Adelaide:
 - The condition of trees... (is) likely to decline as soils dry and evapotranspiration increases
 - Increasing frequency and intensity of heatwaves may reduce tree condition with associated risks to public safety as well as amenity

We therefore strongly advocate to Council:

- No Picnic Shelter for Glenwood Reserve, but maintain the existing informal picnic setting (which visitors obviously appreciate)
- As an alternative, investigate a more sophisticated upgrade to Glenwood Reserve (& Park Drive median), addressing the core management issues of tree health and heritage protection. We suggest an initiative based on the following "adaptation options" for public open space in *AdaptWest 2016*:
 - Implement efficient irrigation practices to maximise greening of open space [immediate]
 - Reduce reliance on potable water to irrigate public open space and increase alternative water sources, including stormwater capture and re-use [immediate]

A local Water Sensitive Urban Design (WSUD) facility to capture local stormwater and recharge the shallow aquifer could improve the climate resilience of the trees, and provide biodiversity and visual amenity benefits. It would align well with Council's *Tree Canopy Improvement Strategy 2021-2045* and the recent Emergency Declaration.

In short, we believe a climate adaptation initiative which protects the heritage trees and maximizes the greening of open space - should be given primacy over other potential investments.

Deputation to Council - 15/3/2022 - Notes for Don Lee comments.

Apart from the matter of the shelter, we seek your permission to submit a detailed initiative in support of council's new Growing Green climate change policies. This initiative relates to 62 trees providing a significant canopy in Glenwood Reserve and the adjacent median in Park Drive, both in Kidman Park. A group of local residents, with the help of Tim, as our ecologist, has assembled a detailed document containing relevant information and suggestions. If you agree this will be submitted shorly

Apart from needing to preserve this large canopy, 44 of those trees are River Red gums, planted on the 1874 Fulham Park Stud. Council has listed these as part of its Heritage Places and as such they are deserving of Council's support. With sufficient water, these trees are capable of living for hundreds of years. An example is on Riverway, where that tree's proximity to the river allows it to thrive.

The third reason for Council to support our initiative, is that these big trees, on Council land, meet State requirements for Significant and Regulated trees and as such need to be protected by Council.

Our detailed submission will suggest that there is urgency as some of the trees are not in good condition and, two summers ago, five of them died. That 2019 summer was unusually hot and dry. The Bureau of Meteorology's records for that summer include the following comments. "the 2019 annual temperature anomaly is 1.5C plus" and "Adelaide rainfall in 2019 was "very much below average". It is believed that the principal source of water for these big trees is from the shallow aquifers underlying the area and likely that the water levels in those aquifers reduced or dried out.

The loss of these five trees is not the only indicator of stress, as two major limbs have fallen from the southernmost trees in the last year and the condition of some trees is poor.

The subsequent two summers have been relatively moderate and no more trees have died. However, that period was moderated by the la Nina effect. That moderation is coming to an end now and we will return to the el Nino effect bringing higher temperatures and lower rainfall. A temperature increase of 1.9 degrees Centigrade is projected. This situation brings urgency to the matter and we will be suggesting the interim use of drip irrigation for use until an enduring measure is found. 6.18 EXTERNAL GRANT FUNDING ACCEPTANCE - WEEKLY FOGO TRIAL

Brief

Green Industries South Australian (GISA) has offered Council grant funding for a pilot program of weekly food and organics collection (FOGO). The grant application was submitted for a proposed 12 month "op-out" 1,000 household pilot program which will see the collection frequency of the 240L FOGO (green lid) bin shift to weekly for these households in the trial, while the 140L general waste (blue lid) bin collection frequency of the trial households will move to fortnightly in order to increase the amount of food organics being recycled via FOGO bins. This model has been successfully trialled across other Local Government areas including the City of Holdfast Bay here in South Australia.

GISA offered Council a grant of \$70,305 to support the implementation of the pilot project to 1,000 households.

8.03 QUESTIONS ON NOTICE - COUNCILLOR STUART GHENT - RECYCLING WASTE DIVERTED FROM THE THREE BIN SYSTEM

Brief

Domestic waste information and education is the best way for our residents to learn what goes in what bin and what does not go into the standard three-bin waste system. Our Council has much useful information on our websites, quarterly newsletters to whole of community, information posters and loose information sheets for recycling waste into the three waste bins. Documentation and internet advice of the environmental benefits of 'do's and don'ts' of domestic waste must be separated, as well as retailing businesses who accept additional recycling waste that has a marketable value which underpins the overall success of recycling in SA. The decisions residents make when lifting the appropriate lid to dispose of their waste in the appropriate council bin or can be recycled by another business has a huge impact of the success of recycling.

I've visited on a number of occasions the Wingfield recycling complex, CAWRA (joint venture with our Council and Port Adelaide Enfield Council), Beverley Recycling and Waste Centre, and noting the amount of non-three-bin recycle material that becomes landfill.

I've also noticed the kerb-side domestic hard rubbish bi-annual residents' pick up service has so many recyclable items which are going to landfill.

Residents should be encouraged to abide by the **Recycling from A-Z | Which Bin SA** <u>https://www.whichbin.sa.gov.au</u> > a-z-items data base, which delineates in detail the do's and don'ts for all domestic waste and when to refer to other agencies, and businesses who will accept additional waste items. This website too often <u>does not refer to the actual</u> <u>businesses and addresses within our city or close by</u>, be it local supermarkets, retail stores and what they will accept as domestic recycle waste.

The Council websites and documentation should also provide where the drop-off points are for these domestic waste items which aren't accepted in the standard three-bin waste stream, such as car batteries, oils, asbestos, and so many more.

Keep these items separated and divert them from landfill. Our goal is to avoid sending *any* recyclables to the Adelaide landfill dumps.

WE DON'T WANT TO SEND ANY RECYCLABLE ITEM TO LANDFILL.


