1. Purpose

The City of Charles Sturt recognises the need to adequately plan for an ageing local population and to consider the needs of our diverse older people in the design and delivery of Council services and facilities. It is created to support people to lead productive and active lives as they age.

This Policy statement is not intended to commit Council to overall service increases or expansion. Rather, it is designed to assist Council to strategically direct its financial, time and lobbying resources to key activities and those likely to have greatest strategic benefit to older citizens.

2. Scope

This Policy is intended as a guide for all business units that have reference and relevance to ageing citizens of Charles Sturt.

The focus of this Policy is to guide the strategic and implementation plans of the Community Connections Portfolio, especially the Ageing Well Team and in this process consider the strategic priorities of South Australia's Plan for Ageing Well 2020-2025.

3. Policy Statement

The City of Charles Sturt will pursue the following strategies to respond to the diverse needs of the City's ageing community supporting them to be valued members of our community.

- 1. Encourage and support independence, active participation and health and wellbeing.
- 2. Encourage a sense of citizenship and of belonging to, and being valued by, the community.
- 3. Create opportunities for community participation, lifelong learning , meaningful connections and the development of social capital.
- 4. Increase access to services through high quality communication, information and customer service.
- 5. Encourage a safe, age friendly and accessible city that values and reflects the needs of all citizens.
- 6. Support philosophies of 'ageing in place' and the provision of adequate, appropriate housing and accommodation options within the city.
- 7. Provide low level services to eligible residents funded by the Commonwealth Home Support Programme (CHSP) funded by the Department of Health and Aged Care via our Ageing Well Team.
- 8. Provide information and resources to our wider community of Aged Care services, and support for older people.
