

6.76 COMMUNITY CONSULTATION RESULTS AND INDUSTRY BENCHMARKING -LIVESTREAMING OF COUNCIL MEETINGS

Brief

At the Council meeting of 22 May 2023, Council endorsed community engagement be undertaken to gauge the communities appetite for livestreaming of its Council meetings. Complimentary to this, Council also endorsed a Motion at its meeting of 13 June 2023, to benchmark all Councils with the aim of gaining insight to the pros and cons of livestreaming. Legal advice was also requested as part of this resolution.

This report is in response to both Elected Member Motions on Notice, and presents the outcomes of the community engagement, industry benchmarking and legal advice.

Some History to start with - 30 years ago in 1993, the number of venues in which South Australian musicians could perform had dwindled to the point where the local live music scene was on the edge of extinction. Worried [about] the breaking of the chain of music being passed on from one generation to the next and that less commercially popular forms of music might disappear from society the Tonkin Family came to the Governor Hindmarsh Hotel with the idea of sharing their vast experience in live music and hospitality with the South Australian public, so they could continue to see and hear the music and musicians they love. Thirty years later there are now 3 generations of the Tonkin Family working within the hotel with the same ongoing vision. Many internationally known artists (such as Paul Kelly, Jimmy Barnes, Jon Stevens and Keith Urban to name a few) have developed their skills and cultivated their audiences in the venue while locally based musicians performed alongside of them. Community based music has always been of the utmost importance to the Tonkins and to this end they have introduced and maintained many different kinds of music "sessions" in the front bar of the hotel. Over 6 nights a week Charles Sturt area musicians get to mingle with choirs, blues bands, American, Irish, and Cajun music styles even a ukulele group with lessons for children and adults. They also have a chance to play songs written in the streets of Hindmarsh in the Hotels and "Open Mic" night on Friday nights. People who played at the hotel as young people are now bringing their children there to learn their musical skills. Many Adelaide High Schools hold their annual concerts in The Venue. The Tonkins have been able to use the activities across the hotel to subsidise all this local, informal music in a way that no other hotel can. They consider community awareness and ability to play music together as their profit. As a business they employ around 60 people at any one time. The Gov has provided employment for many Charles Sturt locals over these years especially as their young employee's study in higher education courses. Even international music star Sia has poured beers there. The Hotels activities have been applauded locally and across Australia. After numerous voting's as the Australian Hotels Associations Best Live South Australian Venue, the association in 2012 accoladed The Gov as the best venue in Australia. It has also won the Australasian Performing Rights Associations inaugural award for Best live Music Venue and in 2012 became the first venue to be included in the South Australian Music Venue Hall of Fame. A few years ago, the Covid 19 Pandemic hit us and businesses such as the Gov were hit hard, they changed their business ways and were still able to bring music to the people by livestreaming nights with the help of our Council from the front bar into people's homes. The Governor Hindmarsh Hotel has been an important cultural asset to the Charles Sturt Community for 30 years and I would like to wish them a Happy Anniversary and thank them for bringing so much music into so many South Australians lives, for no other reason than that they thought it needed to be done.

9.02 MOTION WITHOUT NOTICE - HALTING SAND MINING FROM THE TORRENS OUTLET

Brief

In accordance with the City of Charles Sturt's Code of Practice for Meeting Procedures, Mayor Evans received and accepted a Motion Without Notice from Councillor Kenzie van den Nieuwelaar as the rationale provided by Councillor Kenzie van den Nieuwelaar demonstrated the urgency of the matter.

Motion

That the Mayor writes to the Premier, Deputy Premier and Attorney-General, (copying in the Opposition Leader and Member for Colton) requesting that:

1. Sand mining from the Torrens Outlet be halted indefinitely until the Adelaide Coastal Management Review is completed, noting that;

Forward passing of sand is detrimental to the environment.

An Environmental Impact Statement (EIS) and scientific modelling need to be undertaken to:

a. ensure that further and potentially irreversible damage isn't caused to the West Beach dunes and infrastructure due to forward passing of sand, as there has been insufficient sand nourishment over many years to support this. b. ensure there is no impact on the endangered hooded plovers living in the area.

2. Instead of mining sand from the Torrens Outlet the State Government either;

- a. Remove the State Government directive to the Department of Environment & Water staff to prevent movement of sand from the northern metropolitan beaches to West Beach & Henley South. Counteracting the natural northern littoral drift by moving sand south is scientifically sound and desperately needed to counteract the loss of sand at Henley South without causing further damage and loss at West Beach.
- b. Invest in additional quarry sand to be placed at Henley South to counteract the loss of sand.
